ACDC Report--None

The council reviewed the financial information that was provided by the Arlington Community Development Corporation in order to obtain the 2022 disbursement. Motion was made by Mutziger, seconded by Achterberg to approve the following disbursements—ACDC \$10,000 and \$2000 to the Deferred Compensation Funds for the Arlington Fire Dept and the Arlington Ambulance Service and \$1000 to the BATA bus. All in favor—Carried.

Trevor Keating advised the Council that the Fire Dept. and Ambulance Dept. had voted to become Districts. But with that said, they will each want a contract with the city to determine the price of the trucks, equipment, hall rent, existing funds, deferred comp and a time frame. A committee of Falconer, Johnson, and Lundquist will meet with them to discuss and bring back to the Council. Wilkinson will then work on a contract.

Motion was made by Johnson, seconded by Achterberg to approve the Employee Overtime and Police Report. All in favor—Carried.

The council reviewed the Revenue/Expense, Cash and Utility Reports.

Motion was made by Rowbotham, seconded by Johnson to approve the first reading of the new Ordinance Book. All in favor—Carried.

Storm damage was discussed. Several roofs need repair, but some of the smaller ones have been repaired. We do not need to go out for bid on the two larger ones (fire hall and old shop), but the council was advised to get quotes. There was also discussion about the damage at the cemetery and that there will be some additional trees taken down with the intent to replant next year. The council also decided to take down the old mausoleum at the cemetery as that has come off the foundation and is not being used any more.

The council decided to roll over the Buildings, Liability, Auto, and Airport policies, but will be asking our agent to come to a meeting to discuss coverage so everyone has a better understanding of what is and is not covered.

The council advised the Finance Officer to get a list of older outstanding ambulance bills to Brookings Credit Bureau to aid in collections. They also asked for photos of the skate park jumps that are in surplus in DeSmet. The Finance Officer let the

council know that we were too late in applying for a grant for a lift or stairs at the pool, but that we can apply next year. Todd informed the council that he is working on a Residential Car Charging policy.

Discussion was held regarding the SLFRF Water and Wastewater Grant/Funding. We will be asking Banner to attend the next meeting to see what other options we have at this time to reapply for a lower amount to utilize the ARPA funds match.

House numbers on Hickory were discussed, but as they are already established and we cannot go negative with the numbers, we will keep them as they are. We have ordered East and West Hickory signs to help alleviate the confusion for delivery workers.

The city website was discussed, but needs to be taken up with ACDC.

Motion was made by Achterberg, seconded by Rowbotham to declare the old pool and city building cameras, as well as the old copier as surplus items.

Marshal Mix let the council know the crack sealing was completed last week and the chip sealing will be completed this week. The end of 3<sup>rd</sup> Street where there is a "trough" from the rain was mentioned by a council member and Marshal said he will contact the contractor to see why it wasn't completed.

Todd reminded the Council that Cromwell's have until the 12<sup>th</sup> of June to clean up their property or the city can take action to clean it up and charge for doing so.

Mayor's report: Loren Converse contacted the mayor about a culvert. The Mayor will be attending a meeting on June 8<sup>th</sup> in DeSmet regarding Flooding, and he also asked that the last incinerator be removed from city limits.

Motion was made by Johnson, seconded by Achterberg to enter into executive session at 9:26 P.M. for personnel matters. All in favor—Carried.

Motion was made by Achterberg, seconded by Mutziger to come out of executive session at 9:38 P.M. with no further action being taken.

Motion to adjourn was made by Achterberg, seconded by Rowbotham. All in favor—Carried.
