The City Council met as the Zoning Commission. There was no business. Meeting adjourned.

The City Council met in regular session in the Municipal Building. Present on Roll Call were Mayor Amiel Redfish and Council Members: Curt Lundquist, Terry Rowbotham, Garth Johnson, Jesse Steffensen, Rob Achterberg and Cory Falconer. Absent: None.

Motion was made by Lundquist, seconded by Rowbotham to approve the minutes of the January 7<sup>th</sup> meeting. All in favor—Carried.

Motion was made by Johnson, seconded by Lundquist to pre-approve payments prior to the council meetings for payroll, benefits, utilities, sales tax, credit card bill, loan payments, etc. All bills will be presented to the council at the next regular monthly meeting. All in favor—Carried.

Tammy Anderson was unable to attend the council meeting in person, however; a conference call was conducted in which she explained the property valuation changes for the City of Arlington. She advised that all structures—Commercial and Residential will be going up 10% and also all lot valuations will be increasing by 10%. There were 26 "good sales" in Arlington last year which is the reason for this increase. Anyone wanting to file an appeal to meet with the local board of equalization must file a written request with the finance officer by March 14<sup>th</sup>.

Scott Mohror, Banner Associates, met with the council to discuss aspects of the city project that need to be completed in 2019. Scott went over the discussion that was held during the meeting between Banner, Bowes and the City Council Street Committee. At that time Bowes agreed that they would be responsible for paying the engineering fees for the work from the original project that is being carried over into 2019. Any charges for the additions that were made to the project will be the City's responsibility.

Motion was made by Steffensen, seconded by Falconer to authorize the Mayor sign the Amendment to Owner-Engineer Agreement for engineering charges for the additional work that was added to the street project to be completed by July 1, 2019. All in favor—Carried.

Now was the time for Public Comments-None.

Jay DeVries met with the council on behalf of the ambulance squad. Members of the squad were checking out a 2018 diesel demo ambulance from Fire Safety USA with approximately 10,000 miles just prior to the council meeting. That ambulance is basically set up the same as the current ambulance. Jay is still waiting for some final figures as far as installing equipment, etc. The price he was given for the ambulance is \$167,000. Motion was made by Johnson, seconded by Achterberg to authorize the purchase of this ambulance as the necessary funds are available in the Ambulance Trust fund. All in favor—Carried.

Also the finance officer advised that election of officers for the ambulance service for the year had been held at their last meeting with Jay DeVries, President; Cody Doren, Vice President and Sara Sheeley, Secretary-Treasurer.

The Finance Officer shared information that had been sent to the City by Heartland Consumer Power District in response to the possibility of SB66 being carried forward in the senate. The Mayor advised that he has forwarded a letter to be published in the Arlington Sun regarding this matter.

Motion was made by Lundquist, seconded by Falconer to adopt Resolution #2575 as follow:

## **RESOLUTION #2575**

## A RESOLUTION URGING THE LEGISLATURE TO NOT RESTRICT THE ABILITY OF MUNICIPAL ELECTRIC UTILITIES TO ANNEX SERVICE TERRITORY

WHEREAS, the City of Arlington operates a municipal electric utility;

WHEREAS, the municipal electric utilities of South Dakota represent the values of the communities they serve, providing that the operational and rate-setting decisions are made locally, the member of the Community, at Open and Public meetings, and revenues are reinvested locally foster economic development and innovation;

WHEREAS, the municipal electric utilities of South Dakota have consistently been one of the most important economic development resources for job creation in our region by allowing the cities involved to attract businesses with lower costs of power; and

WHEREAS, good jobs are created for families in many regions of South Dakota by this valuable economic development tool;

WHEREAS, any legislation prohibiting cities with municipal electric utilities to annex additional service territory would be harmful to the City of Arlington and to the state of South Dakota;

NOW, THEREFORE, BE IT RESOLVED, that the City of Arlington urges the South Dakota Legislature to vote against Senate Bill 66 or any other legislation the rural electric cooperatives propose that would freeze electric service territory as it would be harmful to the citizens of South Dakota. All in favor—Carried.

The finance officer furnished the council with a copy of correspondence that had been received from DGR advising that after reviewing the current rates feel that no changes are needed at this time. The council also received a copy of the Heartland Report from 2018.

Motion was made by Steffensen, seconded by Falconer to approve the Employee Overtime, Library and Police Report. All in favor-Carried.

There was discussion regarding the charges for building permits; some examples of the new charges would be Fence \$25.00/Patio or Deck \$40.00/Shed 100 sq ft \$70/Unattached Garage-624 sq ft \$121.00/Residence 1085 sq ft with partially finished basement and attached garage \$670.00. Decision will be made at next month's meeting as to whether or not these charges need to be adjusted before implementing.

The Sheriff delivered the renewal for the Agreement for General Law Enforcement Services for the City Council's approval for 2019. The agreement is written with the same hours and fees as 2018.

Motion was made by Lundquist, seconded by Falconer to approve the renewal of the Law Enforcement Agreement for 2019. All in favor—Carried.

The council reviewed the Revenue/Expense, Cash and Utility Reports. The water loss has been fluctuating over the past few months with no answers for the reason.

Motion was made by Falconer, seconded by Achterberg to have the finance officer advertise for sealed bids/quotes for the Crack Sealing and Seal Coating Projects for this summer which will be opened at the March 4<sup>th</sup> meeting.

Additional Items: Area Townships will be invited to the March council meeting, local board of equalization will meet on Monday, March 18<sup>th</sup>, District 2 meeting will be in Madison on March 20<sup>th</sup>, ad will be run for summer help at the pool, painters and someone to operate the concession at the ball park; will contact Dakota Pump to inspect the main lift station; property owners are reminded that they need to keep the snow cleaned away from fire hydrants on their property; and Two Way Radio currently has the timer mechanism for the sirens as repairs are needed to set off the whistles.

Motion was made by Falconer seconded by Achterberg to enter into executive session at 9:35 P.M. for contract matters/personnel matter and possible litigation. All in favor—Carried.

Motion was made by Achterberg, seconded by Falconer to come out of executive session at 9:50 P.M. All in favor— Carried. No action taken at this time.

Motion to adjourn was made by Achterberg, seconded by Steffensen. All in favor-Carried.
